1. A copy of contractors <b>Public Liability Insurance</b> (indemnity up to €6.5m) indemnifying Mayo County Council.
2. Copy of Waste Collection Permit number under the Waste Management Act, 1996 as amended.
3. Licence Fee - (i) €10.00 per day (or part thereof) per 5 metres of road/footpath space (ii) €20.00 per day (or part thereof) per parking space/bay where the skip is placed in a Pay and Display parking area or other specified area.
